## **RACINE COUNTY COVID-19 UPDATE** **March 25, 2020**

### **Overview**

Governor Evers' "Safer at Home" order went into effect at 8 a.m. today. The overarching goal of the order, which is aimed at slowing the spread of COVID-19, is for people to stay at home unless absolutely necessary. The State of Wisconsin has compiled a Frequently Asked Questions document pertaining to the "Safer at Home" order. [You can find the FAQ here](#), and [read the entire order here](#).

Central Racine County Health Department reports two additional confirmed cases of COVID-19, bringing the total for Racine County to eight confirmed cases.

### **Racine County**

The Racine County Emergency Operations Center (EOC), in conjunction with local law enforcement and Fire/EMS agencies, is accepting community donations of facemasks, including hand-sewn masks, and other personal protective equipment as part of a countywide effort to compile needed equipment to combat the spread of COVID-19 (coronavirus). Equipment can be dropped off at any fire or police station in Racine County after 6 p.m. Tote boxes labeled for personal protective equipment donations are located near the entrances. ### **City of Racine**

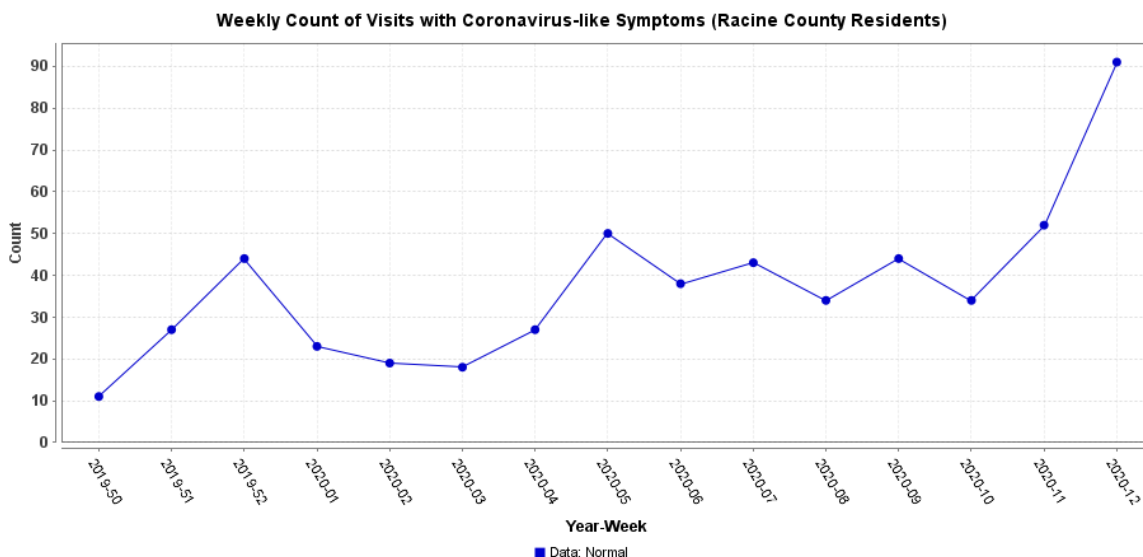
Effective Thursday, March 26, the City of Racine is modifying its bus service to protect public health. Changes include:

- All passengers must board at the rear doors to help maintain social distancing between passengers and drivers.
- Fares to ride the bus are waived until April 20.
- No more than 15 people at a time will be allowed on a bus.
- People with mobility impairments or devices will still be able to board at the front bus door.
- Buses will continue to be disinfected daily.
- Social distancing while on the bus is required.
- Passengers are reminded to only use the bus when necessary, and cover their mouths when they cough or sneeze.

## Public Health

Local public health continues to receive updates regarding testing for COVID-19, with the amount of testing completed based on Wisconsin Department of Health Services' guidance for priority testing and availability of test kits. While the case count remains low in Racine County, the chart below shows those with coronavirus-like symptoms who have presented themselves to hospitals (by year-week) as compiled by Central Racine County Health Department. The first two peaks likely represent influenza while the last is likely coronavirus.
