Central Racine County Health Department

The Central Racine County Health Department (CRCHD) reports five additional confirmed cases of COVID-19, bringing the total for the CRCHD jurisdiction to 15.

CRCHD continues to conduct rapid and thorough investigations of all suspect, probable and confirmed cases of COVID-19 and tracing of contacts, with isolation and quarantine of those who are symptomatic or exposed. CRCHD is supporting high risk/vulnerable populations by working with partners to ensure long term care facilities, healthcare settings, first responders, and other essential workers have the necessary personal protective equipment (PPE) and infection control measures in place to care for residents while reducing the spread of illness. Last, CRCHD continues to disseminate public messaging on the importance of public health

guidance, including staying home and practicing social distancing e.g. Governor Evers' Safer at Home order.

City of Racine

The City of Racine Health Department reports four additional confirmed coronavirus cases since Friday, bringing the city's total to 11.
