## **RESOLUTION NO. 2020-16**

RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING THE ACCEPTANCE OF A WISCONSIN DEPARTMENT OF JUSTICE DIVISION OF LAW ENFORCEMENT SERVICE – SEADOG GRANT IN THE AMOUNT OF \$24,906.00 AND THE TRANSFER OF FUNDS WITHIN THE METRO DRUG 2020 BUDGET

To the Honorable Members of the Racine County Board of Supervisors:

**WHEREAS**, the Wisconsin Department of Justice Division of Law Enforcement Services has approved a grant award to the Racine County Sheriff's Drug Unit in the amount of \$24,906.00; and

**WHEREAS**, grant funding is provided by the State of Wisconsin to support the investigation and response to drug trafficking within the state; and

**WHEREAS**, the Racine County Metro Drug Unit is part of a South East Area Drug Operations Group (SEADOG), a taskforce engaged in the ongoing investigation of drug trafficking operations in the Southeastern Wisconsin region and beyond; and

**WHEREAS**, the Racine County Sheriff's Office requests the acceptance of the DOJ grant monies to ensure continued success of the SEADOG mission.

**NOW, THEREFORE, BE IT RESOLVED** by the Racine County Board of Supervisors that the Sheriff's Office is authorized to accept a Wisconsin Department of Justice Grant in the amount of \$24,906.00 to support the investigation and response to drug trafficking for the period of April 1, 2020 to September 20, 2020; and

**BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that the transfer of funds, as set forth in Exhibit "A" that is attached hereto, within the Sheriff's Office Metro Drug 2020 budget is hereby authorized and approved.
