## **RACINE COUNTY COVID-19 UPDATE** **May 18, 2020**

### **Confirmed coronavirus cases**

United States: 1,496,509

Wisconsin: 12,687

Central Racine County Health Department: 355 confirmed (102 probable); 12 deaths

City of Racine Health Department: 704 confirmed (88 probable); 8 deaths

Racine County total: 1,059 confirmed (190 probable); 20 deaths

### **Central Racine County and City of Racine Health Department**

The Central Racine County Health Department (CRCHD) is reiterating its reopening guidance and recommendations in light of the recent Wisconsin Supreme Court decision. The City of Racine Public Health Department would like to remind residents within the City of Racine and Villages of Wind Point and Elmwood Park that the local "Safer at Home - Racine" order issued on May 13, 2020, remains in effect until 8:00 AM on May 26, 2020. The drive-thru COVID-19 clinic at Burlington ended Friday with 1,662 total tests administered.

### **City of Racine**

Drive-thru testing, conducted by the Wisconsin National Guard, began today at Festival Hall, 5 Fifth Street. Testing will be conducted daily, 9 a.m. to 6 p.m. (or as capacity allows) through Friday, May 22.

### **Racine County**

Racine County-owned ball fields are open in accordance with all local public health regulations and guidance, with the exception of Pritchard Park. Those fields are in the City of Racine jurisdiction and remain closed. Please note that parks staff are developing reservation forms that outline guidelines that players and teams must abide by so that we can help ensure public health in our communities is protected.

Park buildings are planned to be reopened in time for the Memorial Day holiday weekend.
