RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING THE TRANSFER OF \$151,250.00 FROM THE HEALTH SERVICES 2020 BUDGET TO THE GENERAL FUND – RACINE COUNTY ALTERNATIVES PROGRAM 2020 BUDGET

To the Honorable Members of the Racine County Board of Supervisors:

WHEREAS, the Racine County Alternatives Program (RCAP) was transferred from the Health Services fund to the General Fund in the 2020 budget; and

WHEREAS, the transfer will assist in monitoring the tax levy appropriated for the RCAP program so that it is not intermingled with the other Health Services programs which are not funded by the tax levy; and

WHEREAS, as the 2019 year has ended, the non-lapsing funds left in the old accounts must be transferred to the new accounts.

NOW, THEREFORE, BE IT RESOLVED by the Racine County Board of Supervisors that the transfer of funds, as set forth in Exhibit "A" that is attached hereto, from the Health Services 2020 Budget to the General Fund – Racine County Alternatives Program 2020 Budget is hereby authorized and approved.
