To the Honorable Members of the Racine County Board of Supervisors:

WHEREAS, the Bureau of Transportation Safety (BOTS) #FG-2020-RACINE C-05340 Grant allows the Sheriff's Office to deploy deputies to target speeding anytime during the day or night; and

WHEREAS, the Sheriff's Office administers the grant and works with the Town of Waterford Police Department and the City of Burlington Department; and

WHEREAS, the grant is \$54,864.00 of which the Racine County Sheriff's Office will receive \$22,000.00, the Town of Waterford will receive \$17,000.00, and the City of Burlington will receive \$16,000.00; and

WHEREAS, each department is required to provide a local match of 25% of received funds.

NOW, THEREFORE, BE IT RESOLVED by the Racine County Board of Supervisors that the Sheriff's Office is authorized to accept a BOTS Grant in the amount of \$55,000.00 to target speeding for the period of June 1, 2020 through September 20, 2020; and

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the transfer of funds, as set forth in Exhibit "A" that is attached hereto, within the Sheriff's Grant 2020 Budget and the transfer of funds from the Sheriff's Office 2020 Budget to the Sheriff's Office – Grants 2020 Budget is hereby authorized and approved.
