To the Honorable Members of the Racine County Board of Supervisors:

WHEREAS, to better manage and direct the emergency operations within the County during major critical incidents, the Racine County Sheriff's Office requests the creation of the position of a Deputy Emergency Management Coordinator; and

WHEREAS, the Sheriff's Office planned to request the creation of this position in the 2021 budget, but recent events have highlighted and confirmed the necessity and value of creating the position within the 2020 year; and

WHEREAS, the position will be funded through a combination of agency internal revenue and the Emergency Management Planning Grant (EMPG) which is a stable funding mechanism that has been in place for over 30 years.

NOW, THEREFORE, BE IT RESOLVED, by the Racine County Board of Supervisors that the transfer of funds, as set forth in Exhibit "A" that is attached hereto. from the Jail 2020 Budget to the Emergency Management 2020 Budget and within the Emergency Management 2020 Budget is hereby authorized and approved; and

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the creation of one FTE Non-Represented – Exempt E050 Deputy Emergency Management Coordinator position, effective June 15, 2020, as set forth in Exhibit "B" that is attached hereto, within the Racine County Sheriff's Office, is authorized and approved.
