RESOLUTION BY THE FINANCE AND HUMAN RESOURCES COMMITTEE AUTHORIZING THE ACCEPTANCE OF AN EMERGENCY PLANNING AND COMMUNITY-RIGHT-TO-KNOW-ACT (EPCRA) STATE COMPUTER AND HAZMAT RESPONSE EQUIPMENT GRANT IN THE AMOUNT OF \$7,336.00 WHICH WILL BE PASSED THROUGH TO THE SOUTH SHORE FIRE DEPARTMENT HAZMAT TEAM TO DEFRAY EQUIPMENT PURCHASES

To the Honorable Members of the Racine County Board of Supervisors:

WHEREAS, the Computer and Hazardous Materials (Hazmat) Response Equipment Grant is available to assist counties in complying with the statutory requirements for hazmat response equipment; and

WHEREAS, the Emergency Planning and Community-Right-to-Know-Act (EPCRA) State Computer and Hazmat Response Equipment Grant funds will be used to purchase one drone and seven electrostatic sprayers; and

WHEREAS, South Shore Fire Department will match the required 20%.

THEREFORE, BE IT RESOLVED, that the Emergency Management department is hereby authorized and approved to apply for and accept the FY2020 EPCRA Hazmat Equipment Grant in the amount of \$7,335.79; and

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the fiscal note as set forth in Exhibit "A," that is attached hereto, is authorized and approved.
