# #5 - Report by County Board Intern Lea Diaz regarding the State Department of Transportation's projected budget shortfall

County Board Intern Lea Diaz reported on the \$680,000,000.00 projected budget shortfall for the State Department of Transportation. The State would like to implement the following things to close the gap, 1) gas tax increase, 2) annual \$50 fee for hybrid cars, 3) flat use fee for highways, and 4) vehicle tax. She also answered questions from the Committee.

### #6 - Consideration of research projects related to the Governor's budget Motion

Options discussed were: 1) cuts to the U.W. System and the surplus money they have, 2) how positions in the District Attorney's office are allocated, and 3) pay raises in the District Attorney's office. County Board Intern Diaz will report back to the Committee.
