Call to Order

Approval of Minutes of June 8, 2015 Health and Human Development Committee/Human Services Board

Sup. Miller motioned to approve the minutes as submitted. Sup. Dawson seconded.

Discuss Public Hearing Comments

The committee discussed public comments.

Ms. Otto indicated that the Human Services Department (HSD) plans to continue funding Racine Friendship Clubhouse (RFC). HSD has explored additional long term and sustainable funding models for them. HSD is committed to RFC as a partner and definitely plans to work with them moving forward.

Further discussion ensued with regard to available data to interpret the degree of effectiveness of dollars to justify funds being put in one spot and not another. Comprehensive Community Services (CCS) will have metrics. CCS is also a sustainable funding model.

Collaboration was discussed.

Employment skills, life skills, and peer specialists will be increased for next year. Also discussed was training law enforcement to recognize mental illness.

Sup. Miller addressed County Executive Delagrave and asked him to respond to the speakers regarding alcohol and drug court and veteran's court. The County Executive spoke with and indicated that he'll get back to the committee with regard to start up costs, etc. Courts are a best practice and will be looked into during the 2016 budget process.

Sup. Osterman thanked the individuals from RFC for coming out to speak and sharing their stories.

Review 2016 Budget Priorities & Discuss Metrics for Evaluating Budget Priorities

Sup. Miller recommended combining agenda items six and seven. The committee agreed.

Ms. Otto read each goal and measureable outcome. The following changes were highlighted:

HSD

#1 - Application timeliness was increased to 95% from 90%

The average answer rate was decreased to ten minutes from fifteen

Ridgewood

#2 & #3 - The committee agreed to combine these goals.

Set 2016 Budget Priorities

Sup. Miller motioned to set the priorities as reviewed tonight. Sup. Osterman seconded.

Motion carried.

Sup. Miller asked for an update regarding dental coverage.
