*Mirroring trends across the country, COVID-19 cases in Racine County have risen sharply in July, particularly among younger age groups. Racine County is now in the “high risk” category given the current case rate. **How Public Health is Preventing the Spread of COVID-19 in Wisconsin**

**Contact Tracing**

**How it Works**

- Public health is notified if a positive test.
- Public health professionals call to interview the people with a positive test.
- The interview identifies people at risk for infection.
- Identified people are notified.
- Identified people avoid contact with others to prevent further spread.

**Why are public health agencies calling me?**  
Wisconsin public health professionals are working hard to identify and talk to everyone who has been in close contact with someone with a COVID-19 diagnosis.

**What to Expect**

- Your information will only be used for public health purposes.
- Do not volunteer information. You will be asked to confirm certain information we have on file.
- Your answers will help prevent further spread of COVID-19.
- The caller will provide you with helpful information about COVID-19 and your risks.
