

The United States Department of Agriculture (USDA), Food and Nutrition Services (FNS) works very closely with state agencies to ensure that operations of the FoodShare Program are in accordance with all applicable laws and regulations. As a result, program access and customer service reviews are being conducted and have been incorporated into the FoodShare (FS) Management Evaluation (ME) review.

As part of the ME review process, the Department of Health Services (DHS) is requesting your assistance in an effort to gather feedback on your experiences when working with your local Human Service Agency or consortium, specifically your Income Maintenance programs. Surveys must be completed by August 21st.

Local COVID-19 testing has been affected by national testing supply shortages. While the exact impact going forward is uncertain, Racine County has started to see some changes, including Aurora centralizing all of its drive-through community testing sites to Aurora Sinai Medical Center.

Please Note:

Beginning Monday, Aug. 3, the Wisconsin Department of Health Services is launching a COVID-19 Test Result Hotline for individuals tested at National Guard testing sites in Wisconsin. If you've been waiting more than five days for your results, or if you need a copy of your results, call the Wisconsin COVID-19 Results Line at (866) 419-6988. The COVID-19 Results Line is open Monday-Friday from 8 AM – 6 PM. The Results Line only provides test results for COVID-19 testing performed at National Guard testing sites in Wisconsin. Upon calling, you will need to provide the date of your test, the National Guard testing site you visited, your name, and your date of birth. Residents are asked to wait to call the results line until 5 days after your test. Results can also be mailed.
