## **Multi- Discharge Variance**

1. \$7,000 + currently in account. Can be used toward JK project. StepL completed.
2. 70% of money can be used for projects to reduce phosphorus, 30% staff time.
3. Funk's Mobile Home Park, Eagle Lake Sewer Utility, Yorkville Sanitary District, City of Burlington are utilizing the MDV.
4. The Norway/Wind Lake Sanitary District is focusing on P trading with Leo.
5. Western Racine County Sewerage District is using Adaptive Management with Leo.
