4 **ORDINANCE BY THE RACINE COUNTY ECONOMIC DEVELOPMENT AND LAND USE**
5 **PLANNING COMMITTEE CREATING SECTION 20-647 REGARDING AN EXTENSION**
6 **OF THE ADULT ESTABLISHMENT USE ORDINANCE MORATORIUM**

8 **WHEREAS**, on January 28, 2020, the Racine County Board of Supervisors passed
9 Chapter 20, Article VI, Division 22, Section 647, creating a nine-month moratorium on the
10 consideration and/or issuance of zoning permits, certificates of compliance, site plan
11 reviews, and zoning approvals for adult entertainment establishments; and
12

13 **WHEREAS**, this moratorium was adopted in order to permit for a review and revision
14 of Chapter 20, Article VI, Division 22 of the Racine County Code of Ordinances, regarding
15 adult establishment uses; and
16

17 **WHEREAS**, this review is ongoing and the Department of Public Works and
18 Development Services has determined that a revised Division 22 shall be presented to the
19 Racine County Board of Supervisors for its consideration; and
20

21 **WHEREAS**, the revised ordinance, if approved by the County Board of Supervisors,
22 will then be transmitted to the towns in Racine County for their consideration; and
23

24 **WHEREAS**, it is reasonable to extend the moratorium to enable both the proposed
25 amendment to be presented to the Racine County Board of Supervisors as well as
26 sufficient time for town review of the same.

28 **NOW, THEREFORE,**
29

30 Section 20-647 of the Racine County Code of Ordinances relating to an extension of
31 the moratorium is hereby created to read as follows.
32

33 Section 20-647 does ordain as follows: The nine-month moratorium in Section 20-
34 646 previously declared by the Racine County Board of Supervisors, passed on January
35 28, 2020, is hereby extended for a period of ninety (90) days past the date it would have
36 expired, thereby expiring January 26, 2021.
