AMENDING SECTION 12-46(1) OF THE RACINE COUNTY CODE OF ORDINANCES RELATING TO SPEED LIMITS ON COUNTY TRUNK HIGHWAY (CTH) "C".

ORDINANCE BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE

To the Honorable Members of the Racine County Board of Supervisors:

The Racine County Board of Supervisors do ordain as follows:

Section 12-46(1) of the Racine County Code of Ordinances relating to speed limits on County Trunk Highway (CTH) "C" is rescinded and hereby ordained to read as follows:

- (1) County Trunk Highway C.
 - a. Forty-five (45) miles per hour for all vehicle from a point 0.25 of a mile west of its intersection with U.S. Highway "45", easterly to a point 0.20 mile east of said intersection.
 - b. Fifty (50) miles per hour for all vehicles from its intersection with STH "20", easterly to point eight hundred and fifty (850) feet west of its intersection with CTH "V".
 - c. Thirty-five (35) miles per hour for all vehicles from a point eight hundred and fifty (850) feet west of its intersection with CTH "V", to a point eight hundred and fifty (850) feet east of its intersection with CTH "V".
 - d. Fifty (50) miles per hour for all vehicles from a point eight hundred and fifty (850) feet east of its intersection with CTH "V", easterly to its intersection with CTH "H".
 - e. Forty-five (45) miles per hour for all vehicles from its intersection with CTH "H", easterly to its intersection with Summerset Drive.
 - f. Forty (40) miles per hour for all vehicle from its intersection with Summerset Drive, easterly to its intersection with STH "31".
 - g. Thirty-five (35) miles per hour for all vehicle from its intersection with STH "31", easterly to a point 0.53 of a mile east of its intersection with STH "31".
 - h. Thirty (30) miles per hour for all vehicle from a point 0.53 of a mile east of its intersection with STH "31", easterly to a point two hundred and eighty two (282) feet east of its intersection with Colonial Drive.
