The County Board of Supervisors of the County of Racine ordains as follows: Amend the Racine County Zoning Ordinance and change the zoning district for the following described lands from P-2 Recreational Park District to M-4 Quarrying District

## **Legal Description:**

**THE SOUTH** ½ **OF** the Southwest ¼ of Section 7, Township 2 North, Range 19 East of the 4<sup>th</sup> principal meridian.

**Also**, the South 33 feet of the Southeast ½ of Section 7, Township 2 North, Range 19 East of the 4<sup>th</sup> principal meridian lying West of the West line of County Trunk Highway "P".

**Also,** the North  $\frac{1}{2}$  of the Northwest  $\frac{1}{4}$  of Section 18, Township 2 North, Range 19 East of the  $4^{th}$  principal meridian.

**Said** land lying and being in the Township of Burlington, County of Racine, and State of Wisconsin.

The official Racine County Zoning Map is hereby amended to conform to this ordinance.

The Racine County Clerk is directed to transmit duplicate copies of this ordinance by registered mail to the Burlington Town Clerk within seven (7) days after this ordinance is adopted.
