- Antique Boat Show, Reef Point Marina, *September 7 10, 2017
 - Carrie VanDera introduced this item and explained how the ACBS contacted her about bringing the boat show back to the Reef Point Marina as was done in previous years. This would be an antique and classic boat show held on September 7-10, 2017.
 - Mr. Lepping provided the Committee with additional details about the event. He indicated
 this event was originally to be held in New York. but was moved to Racine for 2017 (if
 approved). This is a large international event that will bring thousands of people to the
 lakefront, as well as to local hotels and restaurants in Racine. He said this will be a very
 large boost for downtown Racine businesses. The boats in the show are anything pre1972 that's considered a classic or antique.
 - Supervisor Molnar asked about the site plan and how the marina staff will relocate the
 paid slip holders to other spots in the marina. Ms. VanDera indicated that repeat slip
 holders have already been informed that this event is planned and that the marina staff
 will make sure that all paid slip holders get moved into nearby slips. Since the event is
 just after the Labor Day holiday, there should not be any problem with relocating boats
 within the marina.
 - Discussion by the Committee followed about how exciting this event will be, and that it
 will cover several days. The City of Racine will also be involved with events at Festival
 Hall for this show. The Committee was very enthusiastic about this event and supported
 it, as well as offering to help in any way they can over the next year of preparation.
