Salary off for Family Court Commissioner (FCC) Candidate

The Family Court Commissioner (FCC) Position is a full-time Racine County Employee supervised and appointed by the Circuit Court Judges. The position classified as a grade E090 with a salary range of \$76,314.00 to \$111,421.00. Duties of the FCC include conducting over three-thousand hearings a year for all Divorce/legal Separation cases, Child Support/Maintenance actions, and Paternity cases. Additionally, the position serves a significant administrative role with direct supervision of two full-time Deputy Family Court Commissioners (DFCC), one contracted DFCC, Family Court Workers, and indirect supervision of the Family Court support staff. This position acts as the Director of Family Court Services to oversee the mediation and evaluation programs for the Racine Count Family Court.

On October 19, 2020, our Family Court Commissioner Lorene Mozinski tendered retirement notice effective January 29, 2021. The county advertised the position statewide, the judges conducted interviews, and have selected a replacement.

The candidate selected is currently employed with Racine County as a Deputy Family Court Commissioner. She has served as a DFCC for us since 2004. Additionally, she approximately 32 years of legal experience serving Racine County in Private Practice and as an Assistant District Attorney. She also currently serves as a local Municipal Judge. The candidate's salary requirements are \$105,000 per year.

The Racine Circuit Court Judges unanimously selected this candidate from all of the current applicants. She is highly respected by the family bar attorneys and other in the court system. They felt she was by far the best candidate for the position and they feel the salary requirement is commensurate to the legal and administrative expertise specific to the Racine County Circuit Courts that she has.
