RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE AUTHORIZING APPLICATION AND APPROVAL OF A STP-URBAN LOCAL PROGRAM PROJECT GRANT THROUGH THE WISCONSIN DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENT OF CTH "C", FROM OHIO STREET TO FAIRWAY DRIVE

To the Honorable Members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that the County is authorized to enter into a STP-Urban Local Program Project Agreement in the amount of \$1,175,443.00, as identified in Exhibit "A" that is attached hereto.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the Racine County Public Works Division, or its agent, is authorized to design and construct County Trunk Highway (CTH) "C", from Ohio Street to Fairway Drive.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that this resolution does not authorize expenditure for design or construction, and that the actual allocation of said match monies necessary to carry out the design and construction will be authorized at a later date by the Racine County budget or subsequent resolution by the Racine County Board of Supervisors

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.

**WHEREAS**, Racine County finds it necessary to reconstruct CTH "C", from Ohio Street to Fairway Drive; and

**WHEREAS**, the total construction cost of this project is estimated at \$4,217,760.00; and

**WHEREAS**, the amount of the STP-Urban Grant of federal funds is capped at \$3,042,317.00; and

**WHEREAS**, the STP-Urban Grant of federal funds will fund 80% of the estimated total project cost up to the cap amount; and

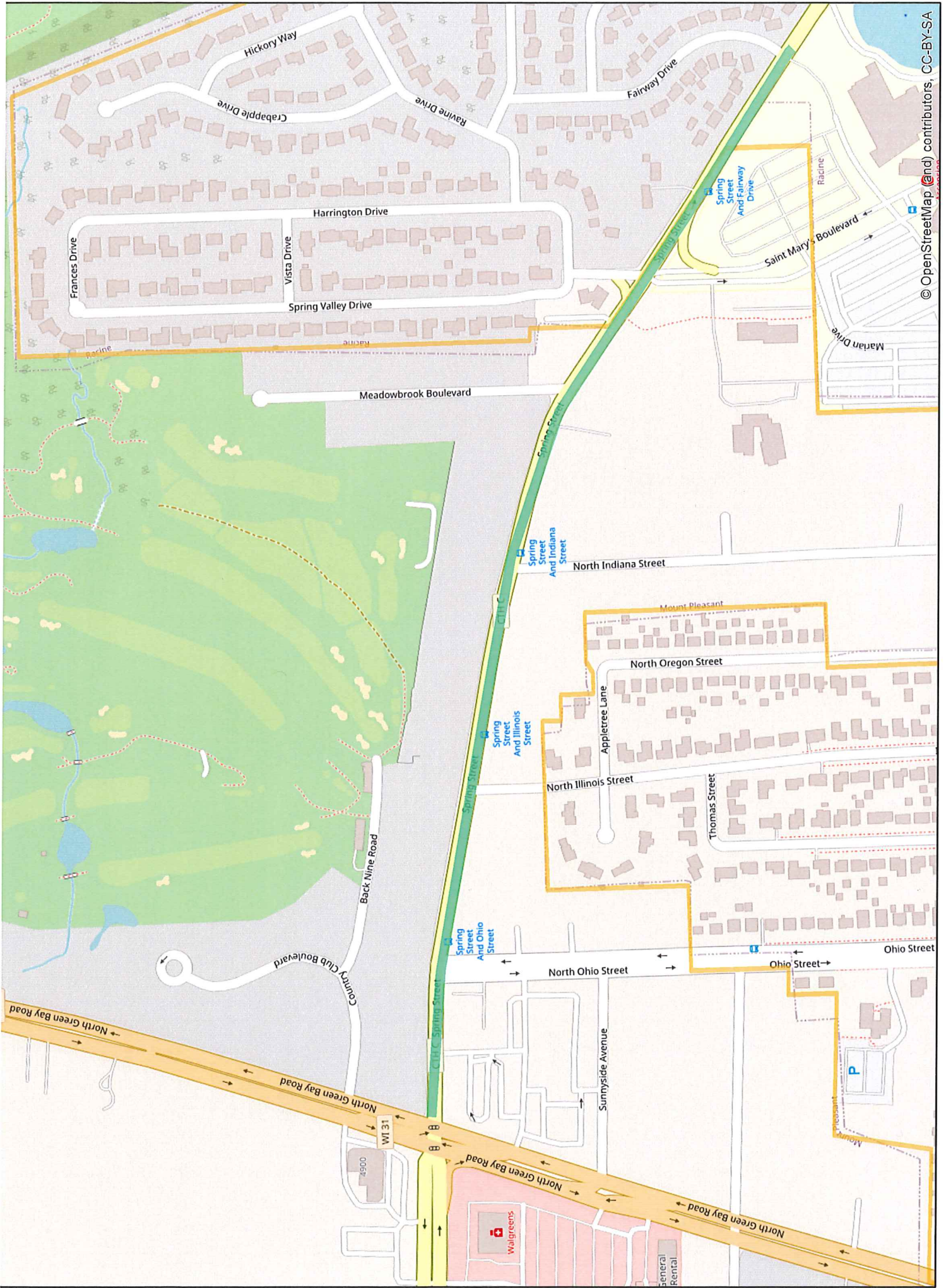
**WHEREAS**, the amount of the STP-Urban Grant of federal funds requires local matching funds of 20% of the total project costs below the federal funding cap; and

**WHEREAS**, the amount of the STP-Urban Grant of federal funds requires local matching funds of 100% of the total project costs once the federal funding cap is met; and

**WHEREAS**, the Racine County Board of Supervisors will authorize and fund the 20% local matching funds plus 100% of total project costs above the federal funding cap in a future annual budget; and

**WHEREAS**, the Racine County Board of Supervisors will authorize and fund with 100% local funds the design for this project in a future annual budget; and

**WHEREAS**, the grant is administered by the Wisconsin Department of Transportation.



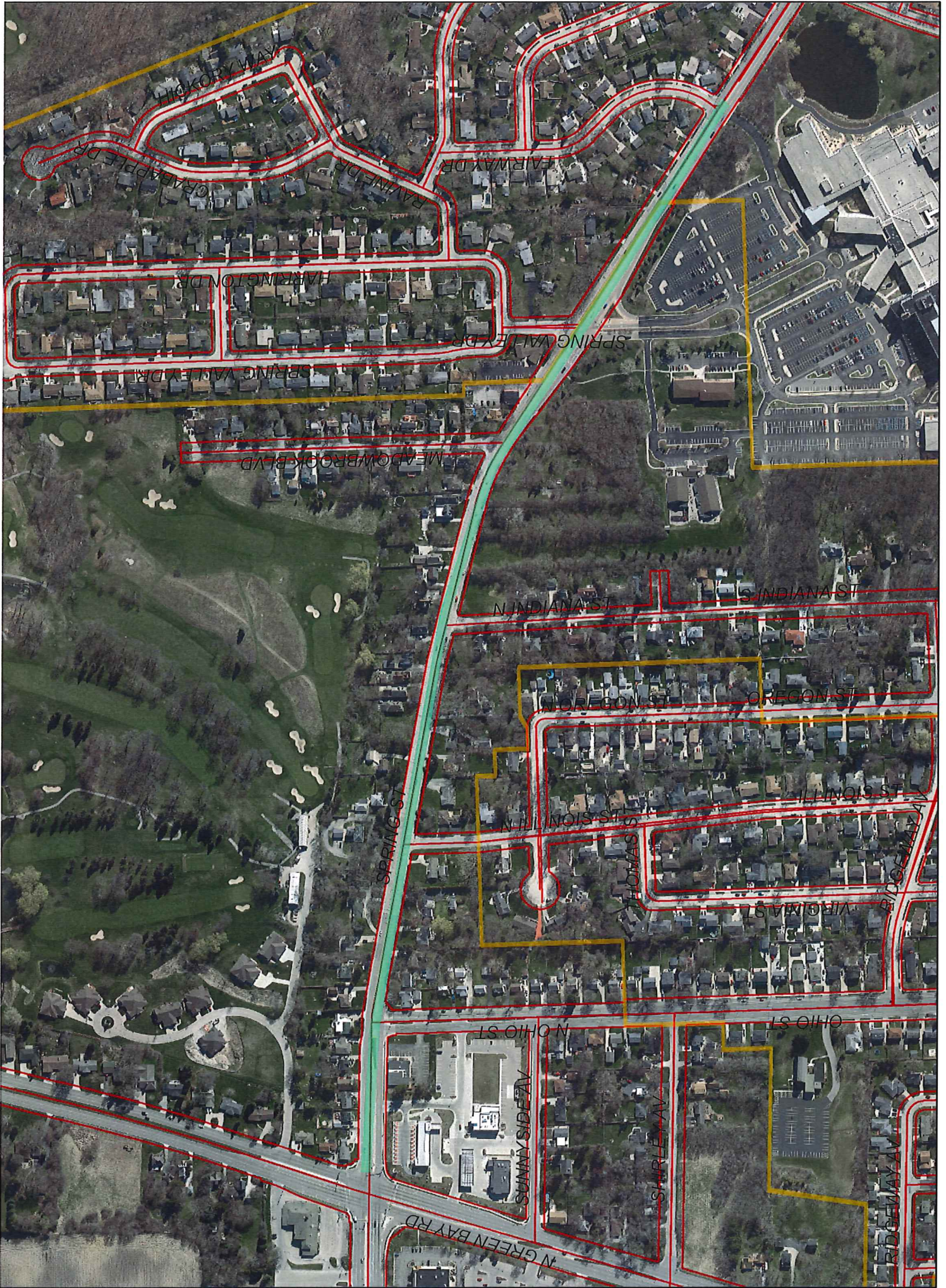
