FARM THE BEST - BUFFER THE REST

Riparian buffers are zones adjacent to waterbodies such as lakes, rivers, and wetlands that protect both water quality and wildlife habitat. These buffer zones help to filter nutrients, slow soil loss and stabilize the bank. Key considerations for buffers/corridors include:

- Wider buffers are better than narrow buffers for water quality and wildlife functions.
- Continuous buffers are better than fragmented corridors for wildlife. Quality wildlife habitat should be provided in a buffer whenever possible.
- Buffers should be located and expanded around rare, threatened, or endangered species. Native species diversity should be promoted through plantings and active management.
- Fragmentation of buffers should be reduced by limiting the number of crossings of a creek or river where appropriate.
- Restoration or rehabilitation of hydrological function, streambank stability, instream habitat, and/or floodplain connectivity should be considered within corridors.



Among the many tools available to farmers to reduce pollutant runoff from agricultural lands, riparian buffers are one of the most simple and cost-effective tools to provide multiple environmental benefits. FY2019 EQIP SIGNUP

EQIP is the primary program available to farmers for farm and woodland conservation work, offering payments for over 110 basic conservation practices. Last year, Wisconsin received about \$35 million in funds for EQIP practices. By getting applications in early, we have time to visit individual farms to help plan all practices needed and offer advice. All eligible applications received by November 16, 2018, will be evaluated, prioritized and ranked for funding in 2019. Farmers and landowners may contact NRCS at 262-878-1243 x 3 to get started on producer eligibility and planning. If you are interested in practices that may require permits, such as manure storage or streambank restoration, begin planning and seeking permits as soon as possible. Applicants with shovel-ready projects (designs completed and permit applications submitted) will receive higher priority.

CONSERVATION CLIENT GATEWAY

Farmers and private landowners can now do business with NRCS through an easily accessible online portal. The Conservation Client Gateway gives producers and entities the ability to work with conservation planners online to access Farm Bill programs, request assistance, and track payments for their conservation activities. The portal enables farmers and private landowners to securely:

- Request NRCS technical and financial assistance.
- Review and sign conservation plans and practice schedules.
- Complete and sign an application for a conservation program.
- Review, sign and submit conservation program contract documents.
- Document completed practices and request certification of completed practices.
- Request and track program payments.

WATERSHED PROTECTION COMMITTEE OF RACINE COUNTY (WPCR): LEADING EFFORTS IN EROSION CONTROL AND WATER QUALITY

The Watershed Protection Committee of Racine County (WPCR) is a team of local farmers leading efforts in erosion control, water quality improvement, and providing information to farmers and rural landowners regarding the use of conservation practices. The group hosts educational workshops and field days and promotes the implementation of conservation practices including cover crops, no-till, and riparian buffers. The committee currently aims its conservation efforts at three watersheds in the county but intends to add more in the near future. These currently are the Eagle Creek, Hoosier Creek, and Goose Lake Branch Watersheds. Farmers within these watersheds are eligible to receive incentive funding from the WPCR for utilizing cover crops and buffers. With a mission to "establish growing conservation knowledge to improve land and water quality" the WPCR hopes to improve conservation in Racine County.

2019 ACREAGE REPORTING DEADLINE IS FAST APPROACHING

In order to comply with FSA program requirements and be eligible for payments, all producers are encouraged to visit your local FSA office to file an accurate crop certification report by the applicable deadline for the 2019 Crop Year:

November 15, 2018: Per ennial Forage, Fall Mint, Fall-seeded small grains, pasture, rangeland, and forage **November 20, 2018:** Honey Bee Colonies and Maple Sap

January 15, 2019: Apples, Caneberries, Cherries, Cranberries, Currants, Hops, Huckleberries, Pears, Strawberries Late filed crop reports are \$46 per farm! Postcards are being mailed out to those who have fall reported in the past. If you do not receive a postcard by 11/1/2018, CALL US IMMEDIATELY (262) 878-3353 in Union Grove, (262) 723-3216 in Elkhorn.

MARKETING ASSISTANCE LOANS (MALs) ARE AVAILABLE FOR 2018 CROPS

9 month commodity loans (MALs) provide low cost financing and marketing assistance for commodities such as feed grains, soybeans, wheat, wool and honey, just to name a few. MALs provide producers interim financing after harvest to help them meet cash flow needs without having to sell their commodities when market prices are low.

MARKET FACILITATION PROGRAM

The sign-up period for MFP is now open and runs through Jan. 15, 2019, with information and instructions provided at www.farmers.gov/mfp. MFP provides payments to cotton, corn, dairy, hog, sorghum, soybean, and wheat producers who have been significantly impacted by actions of foreign governments resulting in the loss of traditional exports. Eligible producers should apply after harvest is complete, as payments will only be issued once production is reported.
