## RACINE COUNTY COVID-19 UPDATE February 1, 2021

### Confirmed COVID-19 cases

United States: 26,231,939 confirmed, 442,207 deaths

Wisconsin: 543,165 confirmed, 2,510,670 negative, 5,897 deaths

Central Racine County Health Department: 10,377 confirmed (+108 from last week), 1,563 probable (+5), 61,253 negative (+254), 193 deaths (+1)

City of Racine Health Department: 7,976 confirmed (+130 from last week), 987 probable (+9), 43,881 negative (+236), 102 deaths (+5)

Racine County total: 18,353 confirmed (+238 from last week), 2,550 probable (+14), 105,134 negative (+490), 295 deaths (+6)

### Vaccination updates for the week of February 1:

- Currently those in Phase 1A (frontline health care workers, EMS, fire and police personnel) and residents ages 65+ are eligible for vaccinations. **Vaccine supply remains limited in Wisconsin.** As of February 1, 13,740 COVID-19 vaccinations have been administered to Racine County residents.
- **Central Racine County Health Department:** This week CRCHD is receiving 17 percent of its requested vaccine. *This means there will be limited vaccine appointments this week.*

  - CRCHD does not yet have the ability to make appointments by phone but is working on this. Do not call CRCHD for appointments at this time.
- **City of Racine Public Health Department:**
  - Due to a limited supply of vaccine, the City of Racine Public Health Department is not taking new appointments at this time.

- **Health care providers** are helping vaccinate those in Phase 1A. *For residents ages 65+ who have a local doctor, your local healthcare provider will be reaching out to you.* Most health care providers are asking their patients to please not call hospitals or their doctor’s office to try and schedule a vaccine appointment. - The Wisconsin National Guard is conducting drive-thru COVID-19 testing sites in Racine County at the following locations:
  - Wednesdays through March 10, 10 a.m. to 5 p.m. at the Racine County Fairgrounds, 19805 Durand Ave., Union Grove. Vehicles should enter the fairgrounds from Main Street.
  - Thursdays through March 4, 9 a.m. to 5 p.m. at Festival Hall, 5 Fifth St., Racine. Vehicles should enter at 11th Street and Main Street.
  - Anyone being tested is strongly encouraged to pre-register by visiting <https://register.covidconnect.wi.gov>.
