#### GENERAL INFORMATION

The purpose of these specifications is to relate Racine County's requirements for purchasing asphaltic material as described. **Racine County has an extensive paving schedule planned for 2021.**

#### REQUIREMENTS

**Trucking:** Asphaltic material will be picked up at the plant and hauled by County trucks.

**Asphaltic Material:** Asphaltic material will be used in the repair or resurfacing of highways in Racine County in 2021. Upon request, the supplier must furnish a copy of a mix design report for the mix to be purchased.

**Quantities/Price:** The County makes no guarantees of any specific minimum purchase. The price quoted shall be fixed for the 2021 calendar year regardless of the amount of material purchased. If a fixed price is not available through December 31, 2021 note as such on the Quote Form.

#### CONTRACTOR'S RESPONSIBILITY

To the fullest extent permitted by law, the Contractor shall indemnify, keep and save harmless the County of Racine, their agents, officials and employees, against all injuries, deaths, loss, damages, claims, suits, liabilities, judgments, costs and expenses, which may arise directly or indirectly from any negligence or from the reckless or willful misconduct of the Contractor or his employees, or of any Subcontractors, or any of their Material Suppliers, or employees and the Contractor shall at his own expense, appear, defend and pay all charges of attorneys and all costs any other expenses arising therefrom or incurred in connection therewith, and, if any judgment shall be rendered against the County of Racine in any such action, the Contractor shall, at his own expense, satisfy and discharge the same.
