Brian Jensen reviewed the petition and public hearing testimony using text and maps. If approved, a security bond will be needed for removal in the amount of \$20,000 and shall be required before the zoning permit is issued. The bond will be reviewed by Development Services Staff and Corporation Counsel. A written detail to the abandonment of the site must also meet County Ordinance requirements. The abandonment plan shall be submitted, reviewed, and approved by Development Services department before the permit is issued. This site is equipped for co-location and can have up to three other users on that tower.

STAFF RECOMMENDATION(S)

Staff recommends approval as this use is in accordance with the purpose and intent of Chapter 20. It appears to be permitted by underlying zoning and will provide a valuable service to the community.
