Location Map

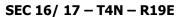

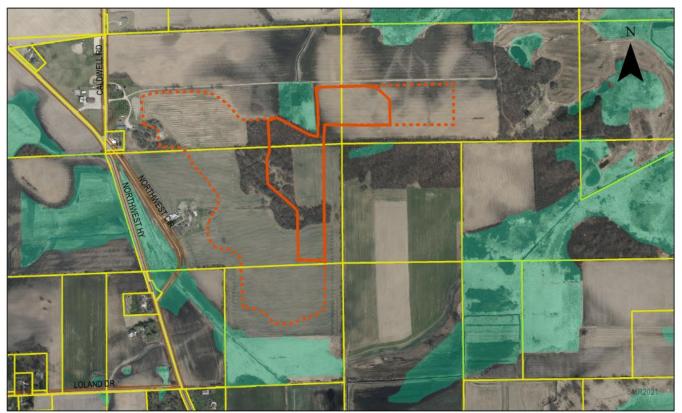

Cross Sections



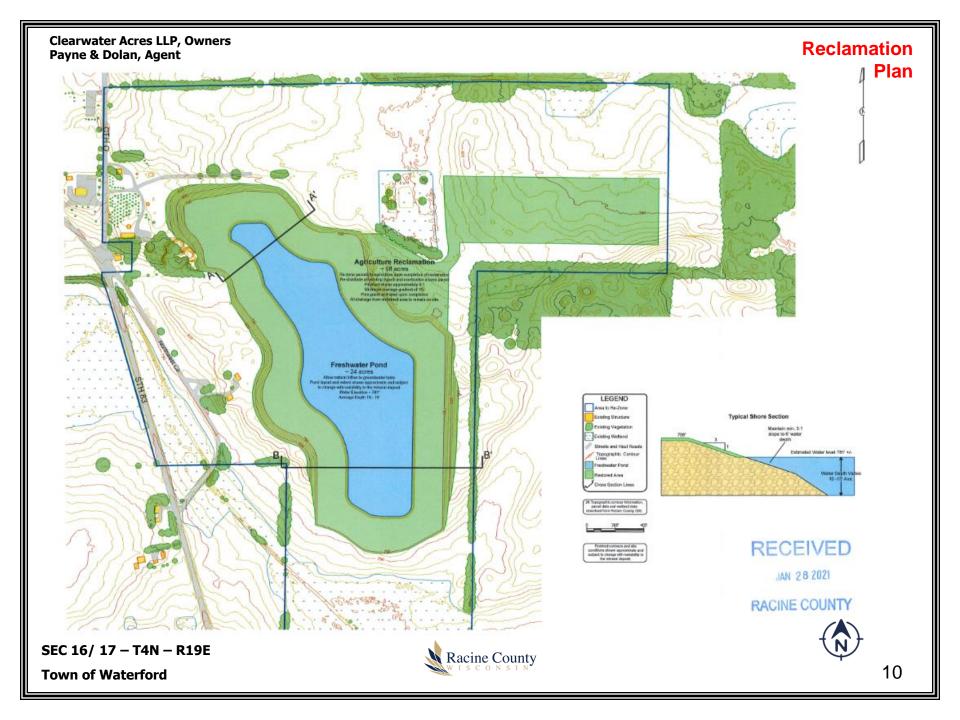


Section A - A' - Looking Northwest

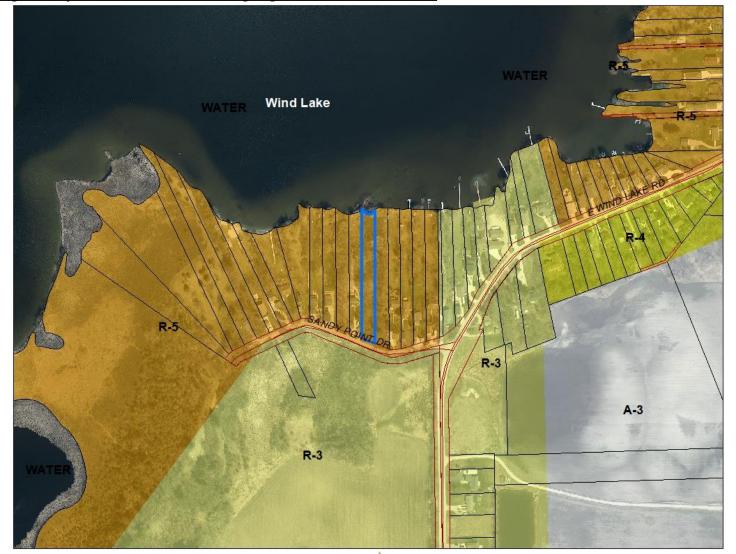

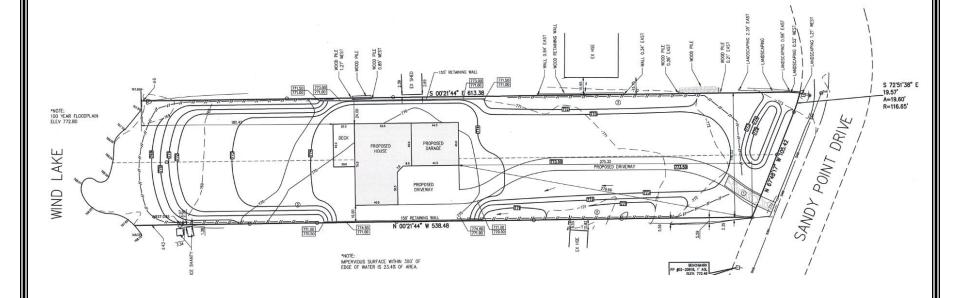

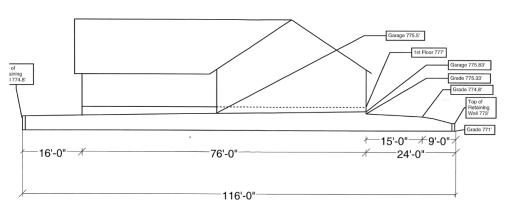




Senese - Sandy Point Lot 14 Conditional Use - FFO Fill Cross Section North South Cut 2.11.2021

North / South Cut

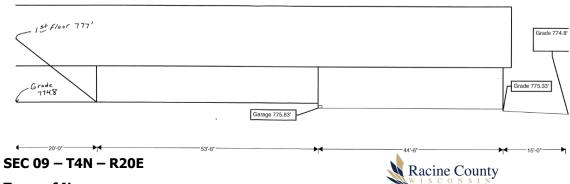

East / West Cut



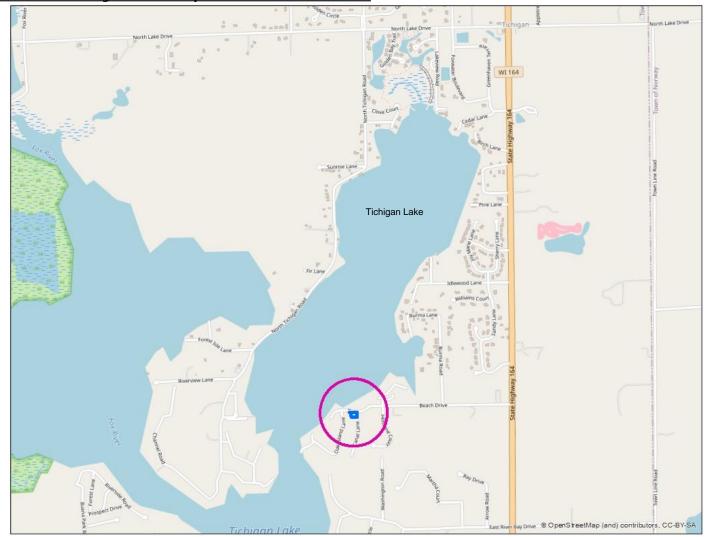

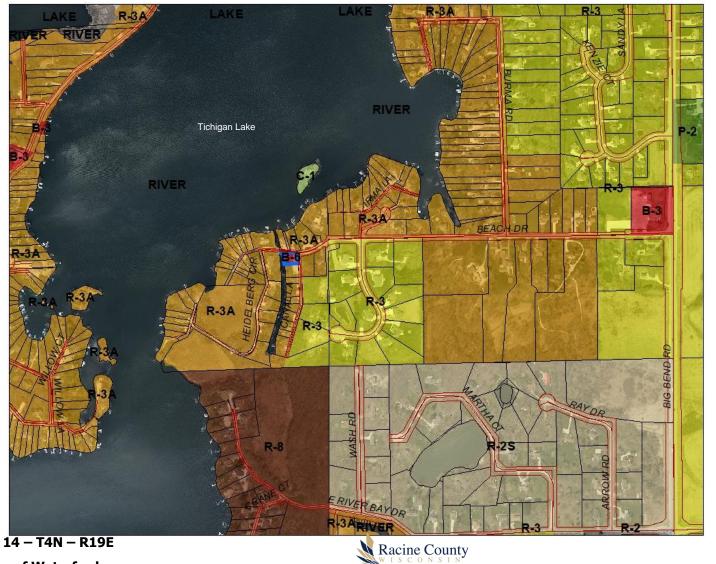

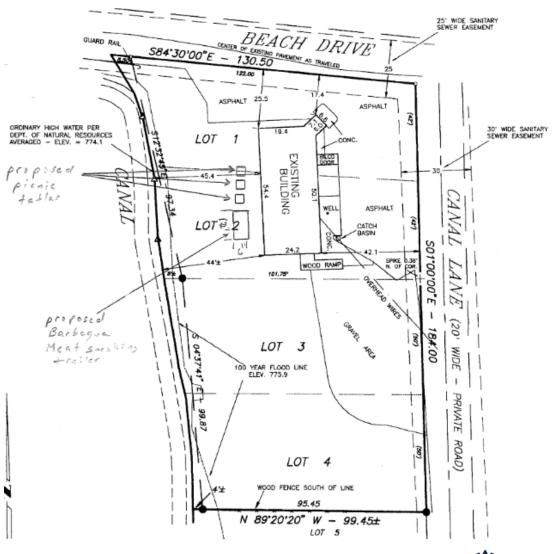

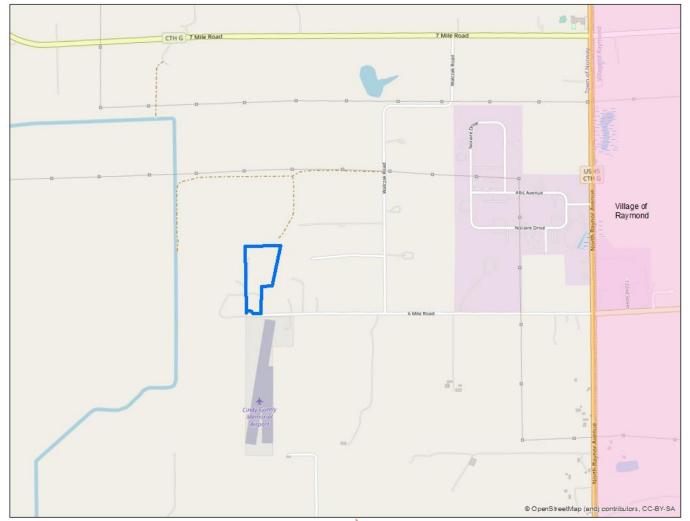

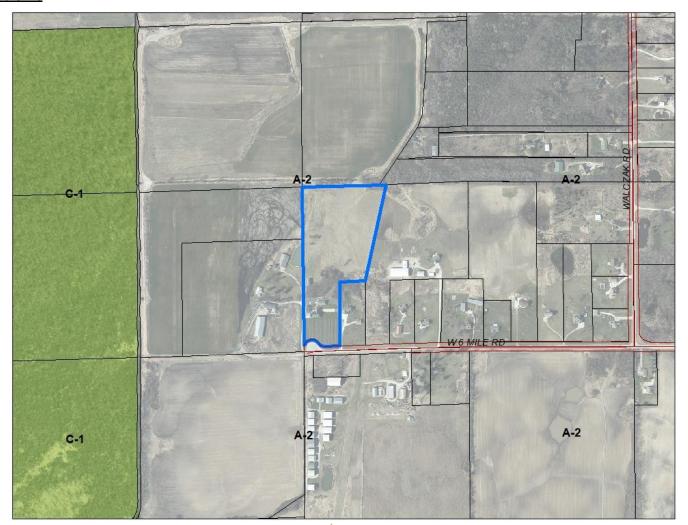
