RESOLUTION NO. 2020-XX

RESOLUTION BY THE ECONOMIC DEVELOPMENT AND LAND USE PLANNING COMMITTEE AMENDING THE LOCATION OF THE PRIMARY ENVIRONMENTAL CORRIDOR LIMITS FOR BLUE HERON POINTE SUBDIVISION, TOWN OF WATERFORD

To the Honorable members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that Racine County approved the residential subdivision plat called Blue Heron Pointe in the Town of Waterford in 1990;

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that there is a primary environmental corridor boundary illustrated on the plat which was a requirement by Racine County when the plat was created.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that the 2020 aerial images indicate changes to the limit of the primary environmental corridor boundary for Lots 1 thru 18 of the plat and that Racine County has the ability to revise or waive the restriction relative to the location of the primary environmental corridor on the affected lots.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that this Resolution amends the primary environmental corridor boundary so that it conforms with the 2020 aerial mapping, thereby eliminating discrepancies between the original subdivision plat and current mapping and allowing staff to use the 2020 map as the official source for location of said corridor for lots 1-18 and noted as "Exhibit A" and attached hereto.
