- \* <u>CREDIT/DEBIT CARD OR ELECTRONIC CHECK</u> Call ACI Payments, Inc. 1-800-272-9829 or go online at <u>www.officialpayments.com</u>. Jurisdiction code for Racine County is **5835**. Service fees are 2.75% for credit/debit card payment or flat fee of \$2.75 for an e-check payment.
- \* PAY IN PERSON (Checks or Cash ONLY):
- 1. **Local Johnson Bank branch locations** Addresses listed on back.
- **2.** Remote Drop Off Site Burlington City Hall, Payments are accepted between 8:00am and 4:30pm (Monday-Friday) at 300 N Pine Street, Burlington. There is also a DROP BOX on the Jefferson Street side of the building.
- 3. <u>Racine County Treasurer's Office</u> Payments are accepted between 8:00am and 4:30pm (Monday-Friday) at the Courthouse, 730 Wisconsin Ave (1<sup>st</sup> floor, north end). We do not accept credit/debit card payments in our office.

If you need a receipt, stop in the office during normal business hours or print one by visiting racinecounty.com/departments/county-treasurer/property-taxes
