Paying Real Estate Property Taxes

What happens if property taxes are not paid on time?

If the current year taxes are not paid in full before September 1st, a Tax Certificate will be issued against the property per Wisconsin State Statute 74.57.

If you fail to pay the outstanding delinquent real property taxes, special assessments, special charges, special taxes, plus interest and penalty, ownership of the property can eventually transfer to the County through the foreclosure process. This transfer can occur two years after issuance of the tax certificate.

The foreclosure process involves fees for title report, certified notices and newspaper publications. These charges are added to your debt and need to be paid, in addition to the delinquent tax balance, if the property is to be redeemed.

THE "TAX" FACTS

- * Real estate property tax bills are prepared and mailed mid-December by the local municipalities. Please contact your local municipality if you do not receive your tax bill or if you have questions (telephone numbers listed on back).
- * Real estate property taxes are calculated on the assessed value. Please contact the Assessor if you have any questions regarding the assessed value of your property (telephone numbers listed on back).
- * The first installment is due by January 31 and paid to the local municipality.
- * IMPORTANT: If any installment payment is late or short, ALL remaining amounts become due and interest and penalty starts accruing as of February 1st. Installment options will no longer be valid.
- * The City of Racine allows taxpayers to pay in four (4) installments payable to the City: January 31, March 31, May 31, and July 31. After July 31, all payments are payable to the Racine County Treasurer.
- * All Other Municipalities have two (2) installment options: January 31 (to municipal treasurer) and July 31 (to Racine County Treasurer). After January 31, all payments are payable to the Racine County Treasurer.

RECOMMENDATIONS

- * Contact your mortgage company to escrow for real estate taxes.
- * Obtain bank financing to pay off delinquent property taxes since interest and penalties continue to accrue at an additional 1½% each month the taxes are delinquent which equals 18% per year.
- * If you are unable to pay your entire tax bill, at least make a partial payment to minimize the balance that is subject to interest/penalty charges.
- * Contact us if you file for bankruptcy, if the property is listed for sale or held in probate.
- * If mailing your payment, ensure that it is post-marked on or before the due date to avoid late fees.
- * Make sure your check is made payable to the Racine County Treasurer, check is signed, the tax key number or address is referenced, and the written amount matches the numeric amount. Banks use the written amount and if incorrect, the check may be returned to you.
- * Check your tax bill each year to make sure you are receiving the Lottery & Gaming credit if you qualify.

- * Continue with payment instructions to complete the transaction.
