#### **Central Racine County Health Department Transition**

Director Otto provided updates regarding the transition of the health department. Everything should be up and running by January 1, 2022.

Jeff Langlieb, Health Officer of Racine County Public Health Department, and Keith Hendricks, Deputy Health Officer Program Manager of the Public Health Department, introduced themselves.

# Ordinance No. 2021-XX Ordinance by the Health and Human Development Committee Creating Chapter 21 of the Racine County Code of Ordinances Relating to the Racine County Public Health Division

Mr. Langlieb introduced the ordinance that has been on the books at the municipal level for years. The fourteen municipalities currently being served have all adopted the uniform set of ordinances to assure consistency across the jurisdiction. This ordinance establishes the health department, the board of health, and most of the provisions are also enumerated statute that gives local authority and context. The rest of the ordinance is related to environmental health.

If this is enacted, Mr. Langlieb will ask the County Board to enact the ordinance and ask the local municipalities to repeal theirs.

Sup. Miller moved to send the ordinance to County Board for first reading November 9, 2021. Sup. Eckman seconded.

#### **Overview of Youth Justice Prevention**

Director Otto introduced Steve Bedwell, the new Youth and Family Division Manager.

Mr. Bedwell referenced the recent violence that involved youth in our community and how HSD has confronted that head-on and has looked at how to prevent it from happening in the future. Mr. Bedwell presented the Youth Justice Prevention Initiatives.

#### Youth Development and Care Center – Timeframe and Approval

Deputy Director Latus provided an update on the timeline of the Youth Development and Care Center. If everything moves forward as planned and is approved, the final approval will be February 28, 2022.

Following discussion, it was decided a two-page information sheet will be created to include a sketch of the facility with bullet points of the new philosophy to share with the committee and the board.
