RESOLUTION BY THE RACINE COUNTY ECONOMIC DEVELOPMENT AND LAND USE PLANNING COMMITTEE RECOMMENDING ADOPTION OF AN AMENDMENT TO THE SOUTHEASTERN WISCONSIN REGIONAL PLANNING COMMISSION (SEWRPC) COMMUNITY ASSISTANCE PLANNING REPORT NO. 337, SANITARY SEWER SERVICE AREA FOR THE YORKVILLE SEWER DISTRICT NO. 1, RACINE COUNTY.

TO THE HONORABLE MEMBERS of the Racine County Board of Supervisors:

WHEREAS this report amends the currently adopted and partially refined Yorkville sanitary sewer service area currently documented in an *Amendment to the Regional Water Quality Plan – 2000 for the Towns of Yorkville and Mt. Pleasant*, dated December 1990.

WHEREAS the plan amendment designates the Village of Yorkville as the management agency that would operate an upgraded wastewater treatment plant and identifies a planned sanitary sewer service area for the Yorkville Sewer Utility District No. 1

WHEREAS the plan amendment was formally adopted by the Regional Planning Commission on September 6, 2020.

WHEREAS the plan amendment was approved by the Wisconsin Department of Natural Resources on December 9, 2020.

BE IT RESOLVED by the Racine County Board of Supervisors that Racine County adopts an amendment to the SEWRPC Community Assistance Planning Report No. 337

BE IT RESOLVED by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive, or the County Board Chairman are authorized to execute any contracts, agreements, or other documents necessary to carry out the intent of this resolution.

BE IT FURTHER RESOLVED that the County Clerk transmit a certified copy of this resolution to the Southeastern Wisconsin Regional Planning Commission (W239 N1812 Rockwood Drive, PO Box 1607, Waukesha, WI 53187) within seven (7) days after this resolution is adopted.
