Res No. 2022-1 1 2 3 Page Two INFORMATION ONLY 4 5 WHEREAS, the Racine Neighborhood Watch serves the City of Racine and the greater Racine area and was locally established in 1982; and 7 8 WHEREAS, unlike other Neighborhood Watch programs, the Racine Neighborhood 9 Watch is designated a 501(c)3 nonprofit; and 10 11 WHEREAS, the Racine Neighborhood Watch works at the neighborhood level and 12 builds productive community law enforcement communications through its Neighborhood Watch 13 meetings, programming, trainings, and events; and 14 15 WHEREAS, though the Racine Neighborhood Watch is a Racine-based program, it 16 performs outreach programming with Racine County municipalities upon request; and 17 18 WHEREAS, the Racine Neighborhood Watch supplies crime prevention tips and best 19 practices to residents of more than 400 organized blocks throughout Racine and Mount 20 Pleasant; and 21 22 WHEREAS, due to the COVID-19 pandemic and other extenuating factors, the Racine Neighborhood Watch is requesting \$35,000 in order to support ongoing community 23 24 programming.
