WHEREAS, in December 2022, Racine County was awarded a Smart Prosecution Grant by the Federal Office of Justice Assistance; and

WHEREAS, the focus of the grant is to improve the way the Racine County District Attorney's Office prosecutes gun crimes in Racine County by using the latest technology to collaborate with local and Federal investigating agencies; and

WHEREAS, the \$323,000.00 grant was approved by the County Board via Resolution No. 2021-101 on January 25, 2022; and

WHEREAS, the budget which was presented for use of the grant funds included hiring a prosecutor for the two-year grant as a contract employee; and

WHEREAS, the contract position has been posted by the State and the County since February, and there have been no applicants who are interested in the contracted employee structure; and

WHEREAS, in the process of interviewing for a State Assistant District Attorney (ADA) position for the office, the District Attorney believes she will be able to fill the position if it is a county job instead of a contracted position; and

WHEREAS, the District Attorney requests that the Board approve using the same grant funds to offer the position as county employee whose term will end at the end of the two years; and

WHEREAS, the pay rate for the grant attorney, classified with the county as a "County Prosecutor", will be the same rate of pay that a State ADA would earn; and

WHEREAS, the entire position and benefits would be covered by the grant.
