Q.A. Shakoor, II is a lifetime Racine County resident who has served his community as both a county supervisor (26 years) and a city alderman (16 years). He has been a member of numerous volunteer, charitable, and community organizations including the FORE Humanity Club, Racine Pin-Hi Golf Club, Boy Scouts of America, Racine Interfaith Coalition, Downtown Racine Steering Committee, Sustainable Racine Advisory Board, Racine Development Group of Racine County Economic Development Corporation, Northside Planning Group, Garfield School Committee, and many others. One notable accomplishment was his collaborative effort to clean up and revitalize the West 6th Street area of Racine. Shakoor played a major role in the collaborative effort which reduced major crime in the area by 94% and sparked neighborhood growth, increased property values, and homeownership.

Shakoor is the recipient of the prestigious Sam Johnson Volunteer of the Year Award (2019). In 2001, he was one of only three individuals in the country to receive the Whitney M. Young Jr. Service Award from the Boy Scouts of America for his work with Troop and Pack 181. Shakoor is a graduate of Washington Park High School and holds a master's degree in management education from U-W Parkside. He worked at Twin Disc for 48 years before retiring from his role as Small Business Liaison Officer, MRO & Commodities Buyer, and Corporate Purchasing.
