## **ORDINANCE NO. 2022-7-S**

ORDINANCE BY THE EXECUTIVE COMMITTEE AMENDING THE RACINE COUNTY CODE OF ORDINANCES – CHAPTER 2, ARTICLE II, DIVISION 5 – COMMITTEES, SEC. 2-124. – SAME—ENUMERATED; DUTIES.

To the Honorable Members of the Racine County Board of Supervisors:

The Racine County Board of Supervisors does ordain as follows:

Chapter 2, Article II, Division 5 – Committees, Section 2-124(a)(2) of the Racine County Code of Ordinances relating to standing committees of the board of supervisors is hereby amended to read as follows:

## Sec. 2-124(a)(2). - Same—Enumerated; duties.

(2) Executive committee. This committee shall be comprised of the board chairman, the vice-chairman, the chairman of the economic development and land use planning committee, the chairman of the public works, parks and facilities committee, the chairman of the health and human development committee, the chairman of the finance and human resources committee, the chairman of the government services committee, and up to three (3) additional county board supervisors appointed by the board chairman. If the board vice-chairman also serves as the chairman of a standing committee, the vice-chairman of such committee shall serve on the Executive committee. If the chairman of a committee cannot attend a meeting, the vice-chairman of that committee can attend in his place. This committee shall have referred to it all matters relating to land acquisition or disposal (excluding highway and parks), elected officials, ethics, community development block grants, local affairs, and county board rules.
