

Modification A to Contract #22-170

This contract modification is between RACINE COUNTY HUMAN SERVICES DEPARTMENT whose business address is 1717 Taylor Avenue, Racine, Wisconsin 53403 and Provider BABY EXPRESS WELLNESS CENTER INC, whose principal business address is 2913 Durand Avenue, Racine, Wisconsin 53403.

The modification to this agreement will be in effect from June 1, 2022, to December 31, 2022. The Provider agrees to abide by all of the terms of the original agreement dated January 1, 2022, through December 31, 2022, with addition of the following:

Increase Commute to Careers by \$30,000, increasing total allocation to \$80,000.

Add 5% fuel surcharge, authorized at the discretion of Racine County Human Services Department.

Add Summer Youth Transportation, total allocation \$20,000.

Total contract allocation will increase to \$100,000

Multiple passenger vans are needed for trips 10 miles or more that require travel times of 45 to 90 minutes. Due to extended travel times, a maximum of 8 individuals are allowed in the 15 passenger vans.
