

### Waiver Language from Corporation Counsel

- (1) Language in this section should be included in all event materials, including materials created prior to the event (e.g. brochures, invitations, advertisements), as well as in materials distributed at event. For materials distributed at the event, this language may be provided separate from any other materials, in a half/full sheet of a paper in the event folder. Also for materials distributed at the event, best practice would be to include this language in the footer of another document that participants would likely reference (e.g. Agenda; Schedule of Events).

THIS EVENT IS OPEN TO THE PUBLIC. BY ATTENDING AND/OR PARTICIPATING IN THE EVENT, PARTICIPANTS ARE DEEMED TO HAVE GIVEN A FULL RELEASE OF LIABILITY TO EVENT HOLDERS, PRODUCERS, SPONSORS, ORGANIZERS, AND ASSIGNS (“EVENT PARTNERS”) TO THE FULLEST EXTENT PERMITTED BY LAW. PARTICIPANTS ALSO ACKNOWLEDGE THAT THEY MAY BE PHOTOGRAPHED AND AGREE TO ALLOW THEIR PHOTO, VIDEO, OR FILM LIKENESS TO BE USED FOR ANY LEGITIMATE PURPOSE BY THE EVENT PARTNERS.

- (1) Language in this section should be included in the event’s online registration form. Please note as I wasn’t sure whether the form could be easily modified to include a specific checkbox for the waiver language, I offered a few different samples of language **highlighted in yellow** that can be modified to be consistent with what action participants will be asked to perform. While a better practice, participants do not need to be required to “check a box” for the waiver language specifically; simply including this language somewhere on the registration page is sufficient for this event.
