1. Chico's Investments LLC, Owner 6:04 Brian Depies and Chris Bower, 6:23 Agents

Conditional use to construct and utilize 30'x100' additions to three existing self-service storage facility buildings (previously approved); construct and utilize a 30'x115' three-sided self-service storage facility building; to convert the existing commercial building to a multi-tenant building; to increase the outdoor off-season storage facilities and the future construction and utilization of multiple three-sided self-service storage facility buildings; located in the B-3, Commercial Service District, 22841 Durand Ave.; Sec. 26, T3N, R20E, **Town of Dover** (Parcel Id. No's. 006032026-023000; -023001; -023002; -023003).

Brian Jensen reviewed the petition using and public hearing testimony using text and maps. Andrew Baer, owner of Storage Authority, is looking to purchase this property was present to provide his plans for the property and the business and to answer any questions of the committee. Chris Bower, agent, was also available to answer questions. A lighting plan has been created and plantings are being planned for this project. Staffing would be present Monday through Friday from 9:00 a.m. to 5:00 p.m. and available by phone any other time.

## STAFF RECOMMENDATION(S)

Staff recommended approval as the use is compatible with the area's underlying zoning and based on other things going on in the area, the proposed use appears to fit with the uses in the district. All applicable previous conditions from the 1996 to 1999 conditional use approvals remain, if awarded.

If there are any lighting complaints in the future, either the owner will meet with the staff to remedy the situation or if not possible, the item will come back to this committee for resolution.

The Town of Dover approved petition at their July 13, 2022, with condition that the Town Engineer would need to approve for stormwater purposes.
