WHEREAS, Racine County hired Baker Tilly US, LLP as its audit firm in 2012 through a competitive RFP; and

WHEREAS, the relationship has been very successful and with new finance leadership, it's in our best interest to continue a contract with a firm and partner who knows our operations and can assist us in process improvement and increased oversight; and
WHEREAS, due to additional audit requirements around single audit compliance, additional single audit programs, and new Governmental Accounting Standards Board (GASB) standards, our auditors have significantly increased the number of hours required to audit the County from 641 hours in 2017 to 868 hours in 2021; and
WHEREAS, Racine County has received a modest increase over the course of our contract renewals with Baker Tilly from \$92,600 in 2017 to \$102,000 in 2021; and
WHEREAS , Racine County has negotiated a 4.5% increase each year by committing to a five-year contract.
