RESOLUTION BY THE PUBLIC WORKS, PARKS AND FACILITIES COMMITTEE AUTHORIZING RELOCATION AND ACQUISITION OF RIGHT-OF-WAY FOR A HIGHWAY IMPROVEMENT PROJECT AT THE INTERSECTION OF COUNTY TRUNK HIGHWAY (CTH) U AND 7 MILE ROAD IN THE VILLAGE OF RAYMOND

To the Honorable members of the Racine County Board of Supervisors:

BE IT RESOLVED by the Racine County Board of Supervisors that Racine County authorizes the proper improvement and maintenance of roadway at the intersection of County Trunk Highway (CTH) U and 7 Mile Road requiring certain relocation or changes and authorizes the acquisition of additional right-of-way and easements along those portions of CTH "U" and 7 Mile Road in the Village of Raymond.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that under the authority granted by sections 32.05, 83.07, and 83.08 of the Wisconsin Statutes, the Racine County Board of Supervisors authorizes CTH "U" and 7 Mile Road to be relocated and that right-of-ways be acquired, in accordance with the plat attached hereto and incorporated herein as Exhibit "A". A copy of the plat shall be filed with the Racine County Clerk within twenty (20) days after its issue.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that Corporation Counsel is authorized to prepare or review any agreement or other document, with the necessary and appropriate terms and conditions to facilitate this improvement.

BE IT FURTHER RESOLVED by the Racine County Board of Supervisors that any two of the County Executive, the County Clerk and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.
