## CAMPGROUND SITES

- Check-in is 3:00 pm and check-out is 1:00 pm.
- Racine County reserves the right to terminate a reservation if a site is not maintained, is unsightly, and/or guests are causing unreasonable disturbances. Guests will be given a 12 (twelve) hour notice to vacate the site. No refunds for unused night(s) will be issued.
- Guests are responsible for the proper location and placement of recreational vehicles and camping equipment, as well as proper installation of any utility connections.
- Guests who remain on a site after their reservation has ended will be ticketed by deputies and given 24-hour notice to vacate. Any personal items left behind will be disposed of. Unpaid camping fees as well as any fees that may have been generated in disposal of personal items left on camp site will be charged to credit/debit card used in original transaction.
- Up to 6 (six) guests are allowed on 1 (one) **individual campsite**.
  - **Group Campsites** – Maximum of 20 (twenty) guests per site.
- One main camping unit (RV) and 1 (one) tent OR 2 (two) tents are allowed per **individual campsite**.
  - **Group Campsites** – No RVs. Maximum of 10 (ten) tents per site.
- Graywater must be contained and disposed of in the dump station.
- Two vehicles or one vehicle and one trailer are allowed per campsite, in addition to the RV, as long as all vehicles are parked on the designated pad.
- No parking on grass.
- Digging or rain ditching is not permitted.
- Do not tie ropes or tent lines to trees or structures.
- Cutting of tree branches is not permitted and is considered vandalism.
- Wading pools, slip n slides, sprinklers and soakers are not allowed.

## QUIET HOURS

- Quiet hours are 10:00 pm to 7:00 am.
- Noise should not emit beyond your immediate campsite or disturb your neighbors.

## PETS

- Pets are allowed in Racine County Campgrounds and walking trails.
- Pet owners are required to clean-up animal waste immediately.
- Pets are to be kept on a leash no longer than 10 feet and controlled at all times.
- Pets may not be tied to trees.
- Pets are not to be left unattended at any time.

## **ALCOHOL**

- Fermented beverages such as beer and wine are allowed.
- Hard liquor is not permitted.
- Glass bottles are not allowed.

## **VISITORS**

- Visitors are not allowed in the campground between the hours of 10:00 p.m. and 7:00 a.m.
- No more than ten 10 (ten) visitors allowed per individual and group campsites.
- Overflow parking is located on the northwest side of the campground and is available to visitors and guests.

## **WEAPONS**

The following items are not permitted in Racine County Campgrounds:

- Firearms
- Bow and arrows
- Slingshots
- Air guns
- BB guns
- Or any other device designed to discharge flying items.

## **FIREWORKS**

- Fireworks are not permitted in Racine County Campgrounds.
