Gilbert L. Williams

Racine County Circuit Court Case No: 2004CI02

An Order for Supervised Release was signed by Judge Repischak on March 31, 2023. Mr. Williams has been classified as a serious sex offender. The Committee continues to search for a residential placement and has 120 days from that date to identify a residential option.

James Levandowski

Racine County Circuit Court Case No: 2013CI01

The Committee continues to search for an appropriate residential option. On April 3, 2023, counsel for Mr. Levandowski filed an affidavit in support of an order to show cause for a finding of contempt, and the Court entered an Order to Show Cause for Finding of Contempt. The Contempt

hearing has been adjourned to July 14, 2023 at 1:30PM. An opening at one of our current properties has arisen and the Committee plans to discuss whether Mr. Levandowski is appropriate for that residence during the closed session of this meeting.

Dennis Yarber

Racine County Circuit Court Case No: 2014CI02

As previously discussed, the prior Adult Family Home (AFH) at which Mr. Yarber was placed was found to no longer be appropriate, and on April 18, 2023 the Court ordered to have Community Care (his MCO) identify a new AFH for him. On May 22, 2023, the Committee filed a letter with the Court addressed to DHS that identified a new AFH for Mr. Yarber. On June 13, 2023, the Court approved that AFH for Yarber. Ms. Christian confirmed that Mr. Yarber had moved to that new AFH.

Jamerrel V. Everett

Waukesha County Circuit Court Case No: 2004CI01

A petition to revoke order for supervised release was filed on December 7, 2022. On May 25, 2023, the Court considered that petition and at the conclusion of that hearing revoked Mr. Everett's supervised release and ordered he be placed in custody at Sand Ridge Secure Treatment Center (SRSTC). The Office of Corporation Counsel will continue to monitor this case.

Michael Fink

Racine County Circuit Court Case No: 2006CI01

On March 29, 2023, Mr. Fink filed a petition for discharge. The Court has now scheduled proceedings for that matter with a pretrial conference on November 13, 2023, and the court trial to be December 11, 2023. Ms. Christian reported that Mr. Fink has recently been found to have violated a condition of his supervised release; however, DHS is seeking an alternative to revocation (ATR) of his supervised release, so Mr. Fink will remain at the residence in the community at this time. The Office of Corporation Counsel will continue to monitor this case.

James Hinkle

Racine County Circuit Court Case No: 2012CI01

As previously discussed, Mr. Hinkle has been subject to an agreement pursuant to an ATR and his been residing at SRSTC. On April 10, 2023, the Court considered a motion filed by Mr. Hinkle to return to the community; however, the Community Reintegration Team (CTR) responsible for Mr. Hinkle's placement opined that they did not believe he was ready to return to the community on that date, but they requested more time to consider that matter and requested a review hearing to be held in 60 days. On June 19, 2023, that review hearing was held, but the parties again requested another review hearing. The Court therefore has

scheduled another review hearing for July 31, 2023. The Office of Corporation Counsel will continue to monitor this case.

Daniel R. Williams

Racine County Circuit Court Case No: 1995CF1197

Pursuant to the agreement reached under his ATR, Mr. Williams is currently placed at SRSTC. A review hearing is scheduled before the Court on July 7, 2023. The Office of Corporation Counsel will continue to monitor this case.
