17	now houses the Racine Heritage Museum in 1961; and
18	Tiow houses the reasine Fiernage Museum in 1001, and
19	WHEREAS, the Racine Heritage Museum has expressed a willingness to continue their
20	operations of the public museum in the public interest on said premises; and

22	WHEREAS, pursuant to a Memorandum of Understanding by and between the County
23	and the Racine Heritage Museum, the parties previously agreed to enter into a land lease
24	whereby the Racine Heritage Museum would store a portion of its artifact inventory in a storage
25	building located at the Ives Grove Complex in the Town of Yorkville, Racine County, Wisconsin,
26	and said lease is set to expire on August 31, 2023; and
