Jensen reviewed the petition and public hearing testimony using text and maps. Hours of operation would be 8:00 a.m. to 10:00 p.m., seven days a week. The parking plan meetings the minimum requirements. Derek Dube was present to discuss the project and the various events he plans to have at the site. He answered questions of the committee members regarding noise mitigation. Entertainment, such as music, would be indoors.

John Bieringer, the owner, was also present to answer questions.

Stephanie Kuehn spoke in opposition to this petition. Jensen also read a communication of opposition from Jacob Holmes.

STAFF RECOMMENDATION(S)

This use is allowed under the B-3 zoning district and appears to be permitted by underlying zoning. It is consistent with the comprehensive plan and, based on the area, it appears to fit with the district as it is B-3 and the comprehensive plan recognizes as commercial. Staff recommends approval with conditions that the venue activity would cease at 8:00 p.m. and there would be no parking on the roadway. It is also recommended that the applicant works with staff to ensure that the property line in the parking plan allows for adequate parking to meet the minimum code requirements. This petition also needs to obtain Town approval.

DECISION

Supervisor TOM RUTKOWSKI MOVED, seconded by Supervisor Eckman to approve with condition to install a privacy fence or vegetative screening along the property line that would identify where the property is and prevent trespassing. The orientation of parking along the East property line will not be perpendicular to but will be parallel to.
