15 **TO THE HONORABLE MEMEBERS OF THE RACINE COUNTY BOARD OF**  
16 **SUPERVISORS, BE IT RESOLVED** by the Racine County Board of Supervisors that the  
17 dedicated but unconstructed streets described as follows is hereby vacated and  
18 discontinued for public use:  
19

20 Lakeside Drive and Grand View Drive located in Buena Park 3<sup>rd</sup> Addition being  
21 part of the northeast 1/4 and the northwest 1/4 of Section 23, Town 4 North, Range 19 East,  
22 Town of Waterford, Racine County, Wisconsin.  
23

24 Lakeside Drive being vacated in its entirety from the north line of Grand View  
25 Drive to the south line of River View Drive, lying west of Lots 42 through 59, east of Lot 60  
26 and east of Lots 75 through 88 of Buena Park 3<sup>rd</sup> Addition.

28 Grand View Drive being vacated from the west line of Lakeside Drive to the north  
29 line of Buena Park 3<sup>rd</sup> Addition, lying south of Lots 60 through 66, west of Lot 66, east of  
30 part of Lot 67, east of Lots 68 and 69, and north of Lots 70 through 75 of said Buena Park  
31 3<sup>rd</sup> Addition.

33 NOTE: Grand View Drive, according to the recorded plat of Buena Park Addition, contains  
34 an area of land shown as "park" between Lots 69 and 70, which also borders on  
35 the area shown as "Buena Lake".  
36

37 Vacating Grand View Drive as intended would eliminate access to this area and  
38 riparian rights of the public may be affected.
