# 5. Pacer presentation by Engineering staff relating to Road conditions, Budget requirements, and funding.

Frank Pritzlaff, the new Engineering Manager, presented this item. He discussed how road conditions are measured primarily by observation. Physical measures can also be done. The Pacer rating system has been adopted by the DOT and most Municipalities and Counties, where 9 and 10 is excellent, new pavement requiring no maintenance, 7 to 8 is good, minor patching may be done to extend the life of the pavement, 5 to 6 is fair, action taken to preserve the pavement, 3 to 4 is poor, starting to fail and 1 to 2 would be failed and require a full reconstruction.

Ratings are established on a bi-annual basis which will be done this year. This data is uploaded to DOTs program. The DOT uses their system to determine funding. This allows the department to determine the highways needing the most repair and to plan and budget for these projects.

Based on the previous PACER ratings in 2021, the average rating for Racine County highways is 4.3 meaning failing to good status. Most of the highway system needs some type of maintenance and repair. Last year repair was done to County highways P, K and U. It is estimated that this year's rating will be about a 4.6.

Prioritizing is done with a combination of the Pacer rating and the amount of traffic on the road. State funding also plays a factor in what roads receives improvements.

Approximately 8 miles of road work was done last year out of 1176 miles of highway road in the County.
