5. Presentation, discussion, and possible action regarding a request to hold a classic 6:02 car event to benefit F.A.C.T. (Fight Against Child Trafficking) at Franksville Park on Saturday, August 3, 2024.

Pastor Jeff Grant presented the fund-raising event to the committee. The funds would benefit three nonprofit organizations: Feed My Sheep, Kans for K-9's and Fight Against Child Trafficking. There would be no swap meet or crafters. He would like to add motorcycles. He is still looking for live entertainment. The event would be much smaller than his original plan. There would be 5 to 10 food vendors, a raffle, but no swap-meet or craft booths. He would like to add motorcycles and is still looking for live entertainment. The event would be cancelled if it rained that day.

Ben Haas indicated there would be cash sales only for vendors. There are no other events scheduled at the park at this time.

The Finance and Human Resources Committee would vote on this resolution prior to first reading of the County Board on October 19, 2023. The current piece of equipment is from the 80's and has outlived its useful life.

7. Presentation, discussion, and possible action regarding an agreement between
6:17 Racine County Public Works and Development Services and the U.S. Fish and Wildlife Service (USFWS).

Ben Haas presented this item indicating approval of a resolution to go before the County Board is needed. This is a ten-year agreement. The agreement asks there is no substantial development within the seeded area for the ten-years of the County will have to pay back the \$7,500 funding for the seeds provided by the WSFWS. This project is at Cliffside Park.

Supervisor EDWARD CHART moved, seconded by **Supervisor Malacara**, to approve the agreement and forward a resolution to the County board for 1st reading on October 3,2023. **Motion carried unanimously: VOTE: 5/0**

Presentation, discussion, and possible action on a resolution authorizing the conveyance of county-owned land by permanent easement to Wisconsin Electric Power Company (dba WE Energies) to install electric facilities at the Youth Development and Care Center. (Request to go for first reading of the County Board on October 3, 2023).

Roley Behm presented this item as a standard easement to WE Energies to install and maintain electric facilities at the Youth Development and Care Center.

Supervisor MARLO HARMON moved, seconded by **Supervisor Malacara**, to approve the resolution to go before the County Board on October 3, 2023. **Motion carried unanimously: VOTE: 5/0**

9. Presentation, discussion, and possible action on a resolution to accept grant funds to assist in the planning and creation of a pedestrian-bicycle path (Request to go for first reading of the County Board on October 3, 2023).

Ben Haas presented this resolution asking for an 80/20% split with the WI Department of Transportation (TAP) with Racine County's share being 20%. The current bridge is unsafe for pedestrian passage over the Fox River as it is narrow. The grant will assist with the design of the separate path as well.

Supervisor JESSICA MALACARA moved, seconded by **Supervisor Harmon**, to approve the resolution to go before the County Board on October 3, 2023.
