# RESOLUTION BY THE HEALTH AND HUMAN DEVELOPMENT COMMITTEE AUTHORIZING RACINE COUNTY'S PARTICIPATION IN THE NACO PRESCRIPTION/HEALTH/DENTAL DISCOUNT PROGRAM WITH CVS CAREMARK

To the Honorable Members of the Racine County Board of Supervisors:

- **BE IT RESOLVED** by the Racine County Board of Supervisors that Racine County is authorized to participate in the NACo-sponsored Health and Dental Discount program, as described in the attached "Exhibit A", which is provided through a simple application with CVS Caremark to provide health and dental discounts for citizens of participating counties under the following terms and conditions:
- 1. The plan rates are as follows:
  - <u>Prescription Drug Discount Card</u> Free for residents (CURRENTLY IN PLACE).
  - <u>Dental Discount Program</u> \$6.95/month or \$69.00/annual for individuals; \$8.95 month or \$79.00/annual for families.
  - <u>Medical Services Program</u> \$6.95/month or \$69.00/annual for individuals; \$8.95/month or \$79.00/annual for families.
- 2. That there will be no cost to Racine County to participate in the program.
- **BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that the program shall be implemented through the Human Services partner in a manner similar to the previous NACo-sponsored Caremark prescription drug card, and as agreed to by the parties.
- **BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that a contract with CVS Caremark and/or NACo to provide for Racine County's participation in the health and dental benefits program is authorized and approved subject to review by the Corporation Counsel, the Finance Director and the Human Services Director.
- **BE IT FURTHER RESOLVED** by the Racine County Board of Supervisors that any two of the County Clerk, the County Executive and/or the County Board Chairman are authorized to execute any contracts, agreements or other documents necessary to carry out the intent of this resolution.
