#### GENERAL INFORMATION

The purpose of these specifications is to relate Racine County's requirements for purchasing asphaltic material as described.

#### REQUIREMENTS

**Trucking:** Asphaltic material will be picked up at the plant and hauled by County trucks.

**Asphaltic Material:** Hot Mix Asphalt shall conform to all applicable provisions of the 2024 State of Wisconsin Department of Transportation Standard Specifications Sections 450, 455, and 460. Asphaltic material will be used in the repair of County Trunk Highway G in the Village of Caledonia in 2024. Upon request, the supplier must furnish a copy of a mix design report for the mix to be purchased.

**Quantities/Price:** The County makes no guarantees of any specific minimum purchase. The price quoted shall be fixed for the 2024 calendar year regardless of the amount of material purchased. If a fixed price is not available through December 31, 2024 note as such on the Quote Form.

#### CONTRACTOR'S RESPONSIBILITY

To the fullest extent permitted by law, the Contractor shall indemnify, keep and save harmless the County of Racine, their agents, officials and employees, against all injuries, deaths, loss, damages, claims, suits, liabilities, judgments, costs and expenses, which may arise directly or indirectly from any negligence or from the reckless or willful misconduct of the Contractor or his employees, or of any Subcontractors, or any of their Material Suppliers, or employees and the Contractor shall at his own expense, appear, defend and pay all charges of attorneys and all costs any other expenses arising therefrom or incurred in connection therewith, and, if any judgment shall be rendered against the County of Racine in any such action, the Contractor shall, at his own expense, satisfy and discharge the same.
