### 4. Legal updates (Office of Corporation Counsel)

#### James Hinkle

Racine County Circuit Court Case No: 2012CI01

On Friday December 1, 2023, a letter providing the efforts that the Committee has made to locate Mr. Hinkle a residential option was sent to DHS and filed with the Court by the Committee. The Committee continues to search for an appropriate residential option. On February 1, 2024 a Petition for Discharge was filed by Mr. Hinkle and a review hearing was scheduled for April 18, 2024. On April 16, 2024, a Motion to Compel Racine County to

Create Residence was filed by Mr. Hinkle. The scheduled review hearing was held on April 18, 2024 and the Court set it over for a status conference that was held on May 17, 2024 at 2:30 p.m. in front of the Honorable Judge Repischak. At the May 17, 2024 hearing, outside counsel appeared on behalf of the committee. The following briefing schedule was ordered: Committee Brief due on June 28, 2024; Response Brief due on September 13, 2024; and a hearing is scheduled for September 30, 2024 at 1:30 p.m. Our brief should be filed with assistance from outside counsel Thursday or Friday this week.

### Phillip A. Richardson

Racine County Circuit Court Case No: 2018CI01

An Order for Supervised Release was signed by Judge Boyle on May 29, 2024. The Committee continues to search for a residential placement and has 120 days from that date to identify a residential option for Mr. Richarson. The Court has set a review hearing for September 20, 2024, one week before the 120-day deadline, to check the status on placement. The Committee is following up on the specific sex offender classification of Mr. Richarson and hopes to report on that next month.

# **Michael Fink**

Racine County Circuit Court Case No: 2006CI01

Mr. Fink had a Supervised Release Revocation Hearing on December 21, 2023 at 2:00 p.m. before the Honorable Judge Robert Repischak. Ultimately, the Court ordered Mr. Fink's supervised release revoked on February 13, 2024. On June 19, 2024, Mr. Fink filed a petition for discharge. A status conference is scheduled for August 9, 2024 at 1:30 p.m. in front of Judge Repischak.

The Office of Corporation Counsel will continue to monitor this case and notify the Committee of any updates.

# **Gilbert L. Williams**

Racine County Circuit Court Case No: 2004CI02

On February 28, 2024, the Committee Report of Identified Residential Option was sent to DHS and a copy filed with the Court. A review hearing was held on April 1, 2024 at 1:30 p.m. in front of the Honorable Judge Repischak. The Court approved the plan for placement and Mr. Williams was placed on April 30<sup>th</sup>. The Office of Corporation Counsel will continue to monitor this case and notify the Committee of any updates.

#### James Levandowski

# Racine County Circuit Court Case No: 2013CI01

The Court signed an order on August 10, 2023, approving the supervised release plan and Mr. Levandowski was placed at his residence on August 29, 2023. Mr. Levandowski continues to reside at that residence. The Office of Corporation Counsel will continue to monitor this case and notify the Committee of any updates.

# **Daniel R. Williams**

Racine County Circuit Court Case No: 1995CF1197

Mr. Williams had a review hearing regarding his ATR on January 5, 2024 before the Honorable Judge Toni Young. At that hearing, DHS requested a six-month extension of Mr. Williams' ATR pursuant to Mr. Williams' agreement to complete six months of additional treatment. Judge Young upheld that six-month extension during a review hearing on March 8, 2024. The Office of Corporation Counsel will continue to monitor this case and notify the Committee of any updates.

### Jamerrel V. Everett

Waukesha County Circuit Court Case No: 2004Cl01

A petition to revoke order for supervised release was filed on December 7, 2022. On May 25, 2023, the Court considered that petition and at the conclusion, ordered to revoke Mr. Everett's supervised release and Mr. Everett was to be placed in custody at Sand Ridge Secure Treatment Center (SRSTC) and remains there. The Office of Corporation Counsel will continue to monitor this case.

# **Dennis Yarber**

Racine County Circuit Court Case No: 2014Cl02

Mr. Yarber continues to reside at the Adult Family Home ("AFH") where he was placed in June 2023. The Office of Corporation Counsel will continue to monitor this case and notify the Committee of any updates.

Ms. Meinert provided the following updates on HSD's evaluations of the potential properties provided to HSD by Ms. Christman, and HSD's other efforts to identify suitable housing for the pending parties:

June: As of June 21<sup>st</sup>, 493 properties were referred to HSD for evaluation, of which only 42 had not been previously evaluated by HSD for conformity with statutory criteria. Of those 42 properties, 27 met statutory criteria after HSD's preliminary evaluation using the digital mapping tool. Twenty-seven properties were sent to vendors for consideration. No change in the vendor list since November of 2023.

# 6. <u>Discuss-consider process for making recommendation to DHS and Court for Chapter</u> 980 sex offender placement

Attorney Serketich reported that the monthly Statewide meeting of Corporation Counsels to discuss Chapter 980 issues was not held in June as the Milwaukee County Corporation Counsel attorney in charge of scheduling these meeting has left the Milwaukee office. It has been discussed that Attorney Serketich may possibly be taking over scheduling these meetings.

Attorney Serketich did want to provide some follow-up regarding the Dodge County's motion to compel that was discussed last month. The time for a decision has been extended to give the court more time to consider the briefs. A status hearing has been scheduled for mid-July. Corporation Counsel will continue to monitor Dodge County's case.
