Czuta reviewed the petition and public hearing testimony using text and maps. The applicant cannot predict the hours of operation at this time; however, staff suggests hours be limited to 6:00 a.m. to 6:00 p.m. Monday through Friday and 6:00 a.m. to 2:00 p.m. Saturday with no activity on Sundays or holidays as these hours would be like other businesses in the area. Staff would recommend that there be no direct vehicular access to Walczak Road from this property.

Four residents spoke in opposition to this petition mainly due to drainage issues. Lighting and hours of operation, and noise were other issues discussed.

The Town of Norway will hear this petition on September 4th and their Engineer is looking into the drainage in this area.

Brent Ryan was present to answer questions. No fencing or loading docks are planned currently. Discussion of lighting was made.

STAFF RECOMMENDATION(S)

Staff recommends either to layover subject to input from the Town of Norway and revisiting this later or approve it subject to Norway's input on the drainage. Lori Cramer was present to answer the questions of the committee.
