#### #4A - YIG Group 10 Annual Report

Positive Youth Development Educator Gayton-Martinez gave a report of last year's Youth in Governance group. The number of nominations and applicants were similar to years prior. 52 youth were nominated and 27 completed applications and were interviewed. Ten youths were selected to serve and all ten YIG's completed the program. After completion of the program a survey was given that nine youths fully completed, and one partially completed. According to the survey, they experienced the most growth in three areas: knowledge of Racine County government, awareness of local issues affecting the county, and greater confidence that their opinions can make a difference within the community.

### #4B - Determination of recruitment schedule for YIG Group 12, including discussion regarding interviews and review of process

Positive Youth Development Educator Gayton-Martinez answered questions about the process of selection. This included what organizations are reached out to within the community to submit nominations. Nomination forms will be due December 13, 2024. To qualify; students must have a minimum GPA of 2.5, they may not be seniors and must live within Racine County. There was a recommendation to accept more applicants for the purpose of placing them as alternates and give more youth an opportunity to take part in the program. Discussions are to be had regarding reevaluation of the scoring process during interviews. YIG representative Brooks recommended creating a guide to assist nominees with the interview process. Gayton-Martinez also spoke on the potential of receiving the Baldwin Grant. This grant was applied for prior to the September 30<sup>th</sup> deadline and decisions will be made in January 2025. Details of the application can be amended, and Chairman Kaprelian spoke of drawing up an amendment to be voted on at the November meeting.
